### **Executive Summary**

Effective from August 1, 2017, the Canada-Ukraine Free Trade Agreement (CUFTA) aims to improve market access conditions for Canadian and Ukrainian companies, including elimination of tariffs. Upon CUFTA's entry into force, Canada immediately eliminated customs duties for 26.5% of its tariff lines resulting in 98.1% of Canada's tariff lines being duty free for imports from Ukraine. At the same time, Ukraine immediately eliminated custom duties for 34.7% of tariff lines and overall, 72.6% of Ukraine's tariff lines became duty free for imports from Canada.

We analyzed Ukrainian enterprises operating within specific value chains: Packaging and Cardboard, Agricultural machinery, Socks, Plastics and Aerospace. Our focus was on detecting the promising products that these companies import from elsewhere, but instead could import from Canada with more profit. The primary target regions are the government controlled areas of Donetsk and Luhansk oblasts. Therefore, all value chains are analyzed for companies located in these two regions. Moreover, Aerospace and Agricultural machinery VCs are analyzed at the national level.

Target value chains form 0.66% of the gross regional product in Donetsk and Luhansk oblasts. The total sales of Donetsk and Luhansk firms are equal to UAH 6.5 billion, while the value added is UAH 1.6 billion in 2018. The total number of firms is 241.

The biggest value chain is Packaging and Cardboard. It contributes approximately UAH 1.2 billion (0.55%) of value added to the gross regional product of the selected regions. Also it has the highest import potential. The second largest value chain is Agricultural machinery which contribute UAH 323 million (0.14%) to the gross regional product in Donetsk and Luhansk regions. The smallest value chains are Plastics, Socks and Aerospace industry. These value chains contribute approximately UAH 43 million of value added (0.01%).

Top import commodities in Donetsk and Luhansk oblasts VCs are:

- Packaging and Cardboard:
  - Waste and scrap of paper and paperboard (UAH 250-300 mln)
  - Paper and paperboard, coated one or both sides with kaolin (china clay) or inorganic substances (UAH 35-41 mln)
  - Wood pulp obtained by a combination of mechanical and chemical pulping processes (UAH 30-35 mln)
- Agricultural machinery:
  - X-ray, alpha, beta, gamma radiation apparatus: generators, control panels and desks, screens etc (UAH 4.5-5 mln)

- Instruments and apparatus; for measuring or checking viscosity, porosity, quantities of heat, sound or light (UAH 250-400K)
- Boards, panels, consoles, desks, cabinets for electricity control and distribution (UAH 300-350K)
- Socks:
  - Cotton yarn (other than sewing thread) containing more than 85% of cotton (UAH 3.5-4 mln)
  - Cotton yarn (other than sewing thread), containing less than 85% of cotton (UAH150-200K)
  - Base metal mountings, fittings and similar articles (up to UAH 100K)
- Plastics:
  - Machinery for working rubber or plastics or for the manufacture of products from these materials (UAH 650-700K)
  - Taps, cocks, valves and similar appliances for pipes, boiler shells, tanks, vats or the like, including pressure-reducing valves and thermostatically controlled valves (up to UAH 100K)
  - Electric soldering, brazing, welding machines and apparatus, electric machines and apparatus for hot spraying of metals or sintered carbides (up to UAH 100K).

At the national level, Aerospace and Agricultural machinery value chains contribute 0.58% to the Gross Domestic Product of Ukraine. Total sales of Aerospace value chains were UAH 23 billion in 2018 (140 firms), Agricultural machinery VC – UAH 37 billion (2,532 firms). Corresponding value added of both VCs is UAH 9 and 11 billion.

Top import commodities in Aerospace and Agricultural machinery value chains are (at HS4 level):

- Agricultural machinery:
  - Tractors; (other than tractors of heading no 8709) (UAH 234-340 mln)
  - Flat-rolled products, width 600mm or more, clad, plated or coated (UAH 178-234 mln)
  - Harvesting and threshing machinery, straw and fodder balers, grass or hay mowers; machines for cleaning, sorting or grading eggs, fruit or other agricultural produce (UAH 113-137 mln)
- Aerospace industry:
  - Turbo-jets, turbo-propellers and other gas turbines (UAH 201-251 mln)
  - Nickel; articles thereof n.e.c. in chapter (UAH 200-250 mln)
  - Titanium; articles thereof, including waste and scrap (UAH 100-150 mln).

In our study "Canada-Ukraine Free Trade Agreement: Patterns and Tendencies" (2020)<sup>1</sup>, we analysed the CUFTA impact on Canada-Ukraine bilateral trade. One of the main outcomes of the research was identification of promising goods whose exports Canada could increase to Ukraine.

Based on that list of promising goods from our previous study, we identified 17 promising goods for intensifying Canadian exports to Ukraine through the selected value chains in Donetsk and Luhansk oblasts (at HS6 level). The most promising commodities are:

- Packaging and Cardboard:
  - Kraft paper and paperboard; sack kraft paper, uncoated, unbleached, in rolls or sheets, other than that of heading no. 4802 or 4803 (HS 480421)
  - Finishing agents and dye carriers; to accelerate dyeing or fixing of dye-stuffs, other products and preparations, used in the textile industry (excluding those with a basis of amylaceous substances) (HS 380991)
  - Machinery; injection-moulding machines, for working rubber or plastics or for the manufacture of products from these materials (HS 847710)
- Agricultural machinery:
  - Paper pulp, paper, paperboard, cellulose wadding or webs of cellulose fibres; articles n.e.c. in heading no. 4823 (HS 482390)
  - Electrical transformers; liquid dielectric, having a power handling capacity not exceeding 650kVA (HS 850421)
  - Engines; parts, for engines and motors of heading no. 8412 (HS 841290)
- Plastics:
  - Machinery; injection-moulding machines, for working rubber or plastics or for the manufacture of products from these materials (HS 847710)
  - Machinery; parts of the machines of heading no. 8477, n.e.c. in item no. 8477.90 (HS847790)
  - Welding machines and apparatus; for resistance welding of metal, fully or partly automatic, whether or not capable of cutting (HS851521).

We also identified 66 promising goods (at HS6 level) for intensifying Canadian exports to Ukraine through Aerospace industry and Agricultural machinery value chains at the national level. The most promising commodities are:

- Aerospace industry:
  - Turbo-jets; of a thrust exceeding 25kN (HS 841112)

- Turbines; parts of turbo-jets and turbo-propellers (HS 841191)
- Turbines; parts of gas turbines (excluding turbo-jets and turbo-propellers (HS 841199)
- Agricultural machinery:
  - Tractors; track-laying (HS 870130)
  - Iron or non-alloy steel; flat-rolled, width 600mm or more, plated or coated with tin, thickness of less than 0.5mm (HS 721012)
  - Iron or non-alloy steel; flat-rolled, width 600mm or more, plated or coated with chromium oxides or with chromium and chromium oxides (HS 721050).

### Introduction

Canada-Ukraine free trade agreement (CUFTA) came into force on the 1st of August 2017. Since then, it has made a positive impact on the Ukrainian exports to Canada up by  $+6.5\%^2$ . There was also a positive impact on exports of some Canadian products: electrical machinery -6.4%, pharmaceutical products -3.2%, fish -2.1%.

It is also important to analyze what Canadian products are perspective to integrate into Ukrainian value chains (VC) in order to make them more competitive. Particularly, our analysis covered such value chains as: Packaging and Cardboard, Agricultural machinery, Socks, Plastics and Aerospace.

We analyzed Ukrainian enterprises operating within these value chains, as well as their international trade. Our focus was on detecting the perspective products that these companies import from elsewhere but instead could import from Canada with more profit.

Our study of these value chains was conducted for government controlled areas (GCA) of Donetsk (DO) and Luhansk (LO) oblasts, as these regions are partially occupied, and their economic development is crucial for the Eastern Ukraine region. Agricultural machinery and Aerospace value chains for the whole territory of Ukraine.

The report is structured in the following way: Chapter 1 provides the general overview of Eastern Ukraine economy and patterns of foreign trade. Chapter 2 provides an explanation of methodological and technical approaches as well as applied assumptions and definitions. Chapter 3 analyzes an economic significance of target VCs to economies of DO/LO and Ukraine. Chapter 4 identifies the promising goods within target VCs whose exports Canada could increase to Ukraine.

### Chapter 1. Economy of Donetsk and Luhansk oblast

This section provides the general overview of Eastern Ukraine economy and patterns of foreign trade. The conflict of 2014 significantly affected economies of DO and LO oblast. Both regions lost major economic centers and, as a result, regional economies have shrunk and changed their structure, especially LO.

### Donetsk oblast

Figure 1 illustrated the sectoral structure of DO economy. Traditionally, DO economy is dominated by heavy industry (mining, metallurgy, chemistry). The 2014 conflict has not change this pattern. The main economic (nonpublic) sectors are (2018):

- Manufacturing (26%)
- Mining (22%)
- Retail and Wholesalers (7%)
- Real Estate (6%)
- Agriculture (6%)
- Transport (6%)

If we move from the high level aggregation to the lowest available (4 digit KVED codes), 5 largest value chains are (Table A1. Appendix A presents TOP 50 VCs in DO):

- Manufacture of basic iron and steel and of ferro-alloys (Manufacturing)
- Mining of hard coal (Mining)
- Casting of iron (Manufacturing)
- Manufacture of coke oven products (Manufacturing)
- Wholesale of waste and scrap (Retail and Wholesalers)

Tables B1 (Appendix B) presents the list of 107 most imported commodities (HS6) in DO in 2019. This list includes commodities with significantly high import volume (more than USD 1 million). Out of 107 commodities, 20 commodities with the highest 2017-2019 growth are:

• Fertilizers, mineral or chemical; containing the three fertilizing elements nitrogen, phosphorus and potassium (HS6 code: 3105200000):

- Fabrics, woven; plain weave, printed, of polyester staple fibres, containing less than 85% by weight of such fibres, mixed mainly or solely with cotton, not exceeding 170g/m2 (HS6 code: 5513410000)
- Fabrics; knitted or crocheted fabrics of a width exceeding 30 cm, other than those of heading 60.01, containing by weight 5% or more of elastomeric yarn but not containing rubber thread (HS6 code: 6004100000)
- Electric generators; AC generators, (alternators), of an output exceeding 750kVA (HS6 code: 8501640000)
- Vehicles; compression-ignition internal combustion piston engine (diesel or semi-diesel), cylinder capacity exceeding 2500cc (HS6 code: 8703330000)
- Seats; with metal frames, upholstered, (excluding medical, surgical, dental, veterinary or barber furniture) (HS6 code: 9401710000)
- Ignition or starting equipment; starter motors and dual purpose startergenerators, of a kind used for spark or compression-ignition internal combustion engines (HS6 code: 8511400000)
- Metal-rolling mills; parts thereof (HS6 code: 8455900000)
- Boilers; central heating boilers (excluding those of heading no. 8402) (HS6 code: 8403100000)
- Vehicles; spark-ignition internal combustion reciprocating piston engine, cylinder capacity exceeding 3000cc (HS6 code: 8703240000)

- Apparatus based on the use of alpha, beta or gamma radiations, including radiography or radiotherapy apparatus; (for other than medical, surgical, dental or veterinary uses) (HS6 code: 9022290000)
- Machine-tools; parts and accessories, tool holders and self-opening dieheads (HS6 code: 8466100000)
- Footwear; n.e.c. in heading no. 6402, covering the ankle, with outer soles and uppers of rubber or plastics (HS6 code: 6402910000)
- Vehicle parts; drive-axles with differential, whether or not provided with other transmission components, and non-driving axles; parts thereof (HS6 code: 8708500000)
- Vehicles; compression-ignition internal combustion piston engine (diesel or semi-diesel), cylinder capacity not exceeding 1500cc (HS6 code: 8703310000)

• Transformers; n.e.c. in item no. 8504.2, having a power handling capacity exceeding 500kVA (HS6 code: 8504340000)

Table B2 (Appendix B) presents DO potential importers of these commodities.

### Luhansk oblast

Figure 2 illustrated the sectoral structure of LO economy. Traditionally, LO economy is also dominated by heavy industry (mining, metallurgy, chemistry). However, the 2014 conflict has dramatically change this pattern as long as the local industrial enterprises left on the occupied territories. The main economic (nonpublic) sectors are (2018)

- Agriculture (22%)
- Manufacturing (9%)
- Real Estate (9%)
- Energy (8%)
- Retail and Wholesalers (8%)


If we move from the high level aggregation to the lowest available (4 digit KVED codes), 5 largest value chains are (Table A2. Appendix A presents TOP 50 VCs in LO):

- Manufacture of fertilizers and nitrogen compounds (Manufacturing)
- Growing of cereals (except rice), leguminous crops and oil seeds (Agriculture)
- Manufacture of other products of wood; manufacture of articles of cork, straw and plaiting materials (Manufacturing)
- Mining of hard coal (Mining)
- Building of pleasure and sporting boats (Manufacturing)

Tables B3 (Appendix B) presents the list of 47 most imported commodities (HS6) in LO in 2019. This list includes commodities with significantly high import volume (more than USD 500K). Out of 47 commodities, 20 commodities with the highest 2017-2019 growth are:

• Railway or tramway goods vans and wagons; self-discharging, not self-propelled, excluding those of item no. 8606.10 (HS6 code: 8606300000)

- Wood pulp; chemical wood pulp, soda or sulphate, (other than dissolving grades), semi-bleached or bleached, of coniferous wood (HS6 code: 4703210000)
- Machine-tools; bending, folding, straightening or flattening machines (including presses), (other than numerically controlled), for working metal (HS6 code: 8462290000)
- Machine-tools; punching or notching machines (including presses), including combined punching and shearing machines, numerically controlled, for working metal (HS6 code: 8462410000)
- Vehicles; for transport of persons (other than those of heading no. 8702) n.e.c. in heading no. 8703, including station wagons and racing cars (HS6 code: 8703900000)
- Vehicles; spark-ignition internal combustion reciprocating piston engine, cylinder capacity exceeding 1500cc but not exceeding 3000cc (HS6 code: 8703230000)
- Paper and paperboard; uncoated, weight more than 150g/m2 but less than 225 g/m2, in rolls or sheets, n.e.c. in heading no. 4805 (HS6 code: 4805920000)
- Acids; saturated acyclic monocarboxylic acids; acetic acid (HS6 code: 2915210000
- Fabrics, woven; containing 85% or more by weight of textured polyester filaments, printed (HS6 code: 5407540000)
- Vehicles; compression-ignition internal combustion piston engine (diesel or semi-diesel), cylinder capacity exceeding 1500cc but not exceeding 2500cc (HS6 code: 8703320000)
- Metal; catalysts in the form of wire cloth or grill, of platinum (HS6 code: 7115100000)
- Magnesia, fused or dead-burned (sintered); whether or not containing small quantities of other oxides added before sintering, other magnesium oxide, whether or not pure, (not natural magnesium carbonate) (HS6 code: 2519900000)
- Machinery; parts of machinery for making pulp of fibrous cellulosic material (HS6 code: 8439910000)
- Glass; float glass and surface ground or polished glass, in sheets, non-wired, (other than colored throughout the mass (body tinted), opacified, flashed or merely surface ground) (HS6 code: 7005290000)
- Fabrics, woven; of artificial filament yarn, containing 85% or more by weight of artificial filament, strip or the like, printed (HS6 code: 5408240000)

### Chapter 2. Methodology

This section describes the general approach applied to assess shares of specific value chains in the economies of the Eastern Ukrainian regions. Particularly, the section provides a list of targeted VCs and regions of interest; defines activities covered by each VC. Further, the section explains technical details and assumptions behind the VC assessment.

### Value Chains Definition

**Packaging and Cardboard (PC).** This value chain includes manufacturing of packaging materials and containers as well as manufacturing of machinery and equipment for inputs production. The national classification of economic activities (KVED-2010) classifies enterprises and individuals covered by the P&C VC as the following groups:

- Manufacture of wooden containers (KVED-2010: 16.24<sup>3</sup>). This class includes manufacture of wooden packing cases, boxes, trellises, drums and similar packing wooden appliances etc.
- Manufacture of corrugated paper and paperboard, paper and cardboard containers (KVED-2010: 17.21<sup>4</sup>). This class includes production of corrugated and solid paper and cardboard, production of paper bags and sacks etc.
- Manufacture of other articles of paper and paperboard (KVED-2010: 17.29<sup>5</sup>). This class includes production of labels, production of trays for eggs and other paper molded packaging products etc.
- Manufacture of hollow glass (KVED-2010: 23.13<sup>6</sup>). This class includes production of bottles and other containers of glass or crystal, production of drinking vessels and other household articles of glass or crystal.

- Manufacture of plastic containers (KVED-2010: 22.22<sup>7</sup>). This class includes production of plastic products for packaging of goods: packages, sacks, containers, boxes, boxes, bottles, bottles, and more.
- Manufacture of other plastic products (KVED-2010: 22.29<sup>8</sup>). This class includes production of plastic roll products (self-adhesive plates, sheets, film, foil, strips, tapes).
- Manufacture of machinery and equipment for paper and paperboard production (KVED-2010: 28.95<sup>9</sup>). This class includes manufacture of machinery for paper and cardboard manufacturing.
- Manufacture of machinery and equipment for plastics and rubber (KVED-2010: 28.96<sup>10</sup>). This class includes manufacture of machinery and equipment for the production and treatment of soft rubber or plastics, manufacture of articles made of these materials.

**Agricultural machinery (AM).** This value chain includes manufacturing and maintenance of machinery and equipment for agriculture. KVED-2010 classifies enterprises and individuals covered by this VC as the following groups:

- Manufacture of machinery and equipment for agriculture and forestry (KVED-2010: 28.30<sup>11</sup>): tractors, mowers, agricultural machinery for soil preparation, planting or fertilizing etc.
- Repairing and maintenance of industrial machines and equipment (KVED-2010: 33.12<sup>12</sup>): tractors for agriculture and forestry as well as other machinery and equipment for agriculture and forestry.

**Socks.** This value chain includes manufacturing of hosiery and machinery and equipment for the manufacture of textiles, clothing, fur and leather. KVED-2010 classifies enterprises and individuals covered by this VC as the following groups:

• Manufacture of hosiery (KVED-2010: 14.31<sup>13</sup>). This class includes production of hosiery (socks, stockings and tights).

• Manufacture of machinery and equipment for the manufacture of textiles, clothing, fur and leather (KVED-2010: 28.94<sup>14</sup>). This class includes manufacture of machinery for the preparation, manufacturing, molding, stretching, texturing or cutting of chemical textile fibers, materials or yarn, manufacture of machinery and equipment for fabric processing etc.

**Plastics.** This value chain includes manufacturing of plastic construction materials, plates, sheets, tubes etc. KVED-2010 classifies enterprises and individuals covered by this VC as the following groups:

- Manufacture of plastic plates, sheets, tubes and profiles (KVED-2010: 22.21<sup>15</sup>). This class includes production of semi-finished and finished plastic goods.
- Manufacture of plastic building materials (KVED-2010: 22.23<sup>16</sup>). This class includes production of construction products, elastic coatings and artificial stone.

Aerospace. This value chain includes manufacture and maintenance of air and spacecraft. KVED-2010 classifies enterprises and individuals covered by this VC as the following groups:

- Manufacture of air, spacecraft and related equipment (KVED-2010: 30.30<sup>17</sup>): manufacturing of airplanes for the carriage of goods or passengers, helicopters, aircraft parts and accessories etc.
- Repairing and maintenance of aircraft and spacecraft (KVED-2010: 33.16<sup>18</sup>):

### **Target Regions**

The primary target regions are the GCA of DO and LO. Therefore, all VCs are analyzed for companies located in these two regions. Moreover, Aerospace and Agricultural machinery VCs are analyzed at the national level (Table 1). In total, VCs covers 241 companies in DO/LO and 2,672 companies at the National level.

### **Technical Approach**

In order to identify promising Canadian exports to Ukraine of specific VCs, a three-step analysis is conducted.

In the first preliminary stage, the analysis of economic significance of target VCs is carried out. As a measure of economic significance of VC, we used a share of VC value added in the regional economy. The general approach to assessment of the share of VCs in the regional economy is to calculate the ratio of VCs value added to gross regional product (GRP). The GRP is aggregated value added of all industries at the regional level (Equation 1).

#### Share of VC Value Added = VC Value Added / Gross regional product (1)

Due to data limitations, the information on inputs that companies use for their production is unavailable (The State Statistics Service of Ukraine, SSSU, do not provide these data due to confidentially) and VC Value Added is evaluated as a fraction of VC

Total Sale(Equation 2). The SSSU provides Value Added Ratios<sup>19</sup> (VAR) at a highly aggregated industry level.

#### VC Value Added = VC Total Sales \* Value Added Ratio (2)

Therefore, the general formula is transformed into Equation 3:

#### Share of VC Value Added = (VC Total Sales \* Value Added Ratio) / Gross Regional Product (3)

In the second stage, to evaluate the reliance of the selected VCs on imported inputs we calculate two import penetration ratios – measures<sup>20</sup> of the importance of imports in the domestic economy, either by sector or overall, usually defined as the value of imports divided by the value of apparent consumption.

In the analysis, we use two indicators – the share of imports in VC total sales (Equation 4) and the share of imports in VC production costs (Equation 5):

#### *VC sales import penetration rate = VC Total imported inputs / VC Total Sales* (4)

Production costs VC import penetration rate = VC Total imported inputs / VC Production costs (5)

In the final stage, the analysis moves to the commodity level. Firstly, we investigate structure of each VC imports and rank commodities according to their share in total VC imports. Then, we compare the list of commodities imported by the target VCs to the promising Canadian exports to Ukraine identified in "Canada-Ukraine Free Trade Agreement: Patterns and Tendencies" (2020)<sup>21</sup>.

Technically, the analysis of target VCs is described by the following procedure:

- Collecting data about enterprises operating within the selected VCs.
- Calculating shares of the selected VCs in the GRP of Donetsk and Luhansk regions (Aerospace industry and Agricultural machinery in the GDP of Ukraine).
- Estimating import penetration rates for each VC and industry.
- Identifying goods that are perspective to export from Canada in order to integrate into these VCs.

### **Data Sources**

The main data sources used in the analysis include:

- The State Statistics Service of Ukraine provides data on GDP, GRP and Value Added Ratios.
- **RUSLANA Database** assists to identify the list of firms operating in the target VCs and regions as well as provides data on their financial indicators sales and production costs.

You Control Database provide data on commodities imported by Ukrainian firms. Import data is presented in the interval format: lower bound (LB) and upper bound (UB).

### Chapter 3. Share of Value Chain Analysis and Foreign Trade Potential

This section provides results of the assessment of the specific VCs in the economies of Eastern Ukraine regions. Calculations are based on the technical approach described in the previous section and in most cases consist of lower and higher bounds of the value-added share.

### Share of Value Chain Analysis

Selected VCs form 0.66% of the GRP in Donetsk and Luhansk oblasts (the detailed analysis of DO/LO economies is presented in Appendix A). The total sales of DO/LO firms are equal to  $UAH^{22}$  6.5 billion (Table 1), while the value added is UAH 1.6 billion (2018). The total number of firms is 241.

Overall, TOP 5 largest companies are:

- Rubizhne cardboard and packaging mill JSC (Sales 2018 are UAH 4.4 billion).
- Energoinvest (Sales 2018 are UAH 207 million).
- Ukrenergochormet (Sales 2018 are UAH 205 million).
- Resurs-invest LLC (Sales 2018 are UAH 143 million).
- Kristall-99 LLC (Sales 2018 are UAH 89 million).

The chain-by-Chain largest companies are:

- **Packaging and Cardboard:** Rubizhne cardboard and packaging mill private JSC (Sales 2018 are UAH 4.4 billion).
- Agricultural machinery: Energoinvest LLC (Sales 2018 are UAH 207 million).
- Socks: Rubizhne Socks manufacture LLC (Sales 2018 are UAH 34 million).
- Plastics: Interplast LLC (Sales 2018 are UAH 28 million).
- Aerospace industry: TOR LLC (Sales 2018 are UAH 9.2 million).

The biggest VC is Packaging and Cardboard. It contributes approximately UAH 1.2 billion (0.55%) of value added to the GRP of the selected regions. The main industry forming the value chain is Manufacture of corrugated paper and paperboard, paper and cardboard containers, which is 0.48 percentage points out of 0.51%.

The second largest VC is Agricultural machinery which contribute 0.14% to the GRP in Donetsk and Luhansk regions. The main industry forming the value chain is

Repairing and maintenance of industrial machines and equipment: total sales are UAH 1.32 billion, value added is UAH 320 million (2018).

The smallest VCs are Plastics, Socks and Aerospace industry. These VCs contribute approximately UAH 43 million of VA to DO/LO GRP (0.01%).

### National level: Aerospace industry and Agricultural machinery

Aerospace VC and Agricultural machinery VC contribute 0.58% to the Gross Domestic Product of Ukraine (2018). Total sales of Aerospace VC were UAH 23 billion in 2018 (140 firms), Agricultural machinery VC – UAH 37 billion (2,532 firms). Corresponding value added of both VC is UAH 9 and 11 billion (Table 3).

TOP 5 Aerospace VC largest companies are:

- Motor sich JSC (2018 Sales are UAH 12.9 billion).
- Yuzhmash, SOE (2018 Sales are UAH 1.8 billion).
- Lutsk repair plant, SOE (2018 Sales are UAH 1 billion).
- FED, JSC (2018 Sales are UAH 0.9 billion).
- Aviakon Konotop repair plant, SOE (2018 Sales are UAH 0.8 billion).

TOP 5 Agricultural machinery VC largest companies are:

- Metinvest-Promservis (2018 Sales are UAH 2.7 billion).
- Ukravtozapchastina (2018 Sales are UAH 1.5 billion).
- Elvorti (2018 Sales are UAH 0.9 billion).
- Frunze Plant (2018 Sales are UAH 0.9 billion).

Kryvbas-Belaz-Service (2018 Sales are UAH 0.8 billion).

### Foreign Trade Potential of Value Chains

#### Donetsk and Luhansk oblast

This section focuses on target VCs. The total import patterns of DO is presented in Appendix B.

Table 4 illustrates the import penetration indicators assessed for the selected VCs: Sales penetration and Production cost penetration rates.

**Packaging and Cardboard VC has the highest relative and absolute import potential.** Imported inputs contributed UAH 512-564 million in 2018. In relative terms, it is approximately 11-12% of VC sales and 13-15% of VC production costs.

In relative terms, Socks VC is the second largest importer. In 2018, its imports totaled approximately UAH 4-4.5 million: 11-12% of VC sales and 14-15% of VC production costs.

On the other side, **Plastics VC is the second largest importer in absolute values.** In 2018, it imported products of approximately UAH 9.6-12 million: 3-4% of VC sales and 4-6% of VC production costs.

Companies of Packaging and Cardboard VC mostly import Waste and scrap of paper and paperboard (HS 4707), Paper and paperboard, coated one or both sides with kaolin (china clay) or inorganic substances (HS 4810), and Wood pulp obtained by a combination of mechanical and chemical pulping processes (HS 4705) (Table 5). Firms import more than 20 commodity groups (at HS 4 aggregation level), but the top commodities cover approximately 70% of total VC imports: UAH 250-350, 36-41 and 30-35 million respectively.

Companies of Plastics VC mostly import Machinery for working rubber or plastics or for the manufacture of products from these materials (HS 8477), Taps, cocks, valves and similar appliances for pipes, boiler shells, tanks, vats or the like, including pressure-reducing valves and thermostatically controlled valves (HS 8481) and Electric soldering, brazing, welding machines and apparatus, electric machines and apparatus for hot spraying of metals or sintered carbides (HS 8515) Firms import 8 commodity groups (at HS 4 aggregation level), but Machinery for working rubber or plastics cover almost a half of total VC imports: UAH 650-700K.

Companies of Agricultural machinery VC mostly import X-ray, alpha, beta, gamma radiation apparatus: generators, control panels and desks, screens (53-70%) while Companies of Socks VC - Cotton yarn other than sewing thread (82-100%). On the other side, X-ray, alpha, beta, gamma radiation apparatus: generators, control panels and desks,

screens is an outlier as long as it is imported by the only one large company in DO/LO region (TERMO TEHNO UKRAENA LLC).

#### National level: Aerospace industry and Agricultural machinery

Aerospace VC and Agricultural machinery VC contribute 0.58% to the Gross Domestic Product of Ukraine (2018). Total sales of Aerospace VC were UAH 23 billion in 2018 (140 firms), Agricultural machinery VC – UAH 37 billion (2,532 firms). Corresponding value added of both VC is UAH 9 and 11 billion (Table 7).

TOP 5 Aerospace VC largest companies are:

- Motor sich JSC (2018 Sales are UAH 12.9 billion).
- Yuzhmash, SOE (2018 Sales are UAH 1.8 billion).
- Lutsk repair plant, SOE (2018 Sales are UAH 1 billion).
- FED, JSC (2018 Sales are UAH 0.9 billion).
- Aviakon Konotop repair plant, SOE (2018 Sales are UAH 0.8 billion).

TOP 5 Agricultural machinery VC largest companies are:

- Metinvest-Promservis (2018 Sales are UAH 2.7 billion).
- Ukravtozapchastina (2018 Sales are UAH 1.5 billion).
- Elvorti (2018 Sales are UAH 0.9 billion).
- Frunze Plant (2018 Sales are UAH 0.9 billion).
- Kryvbas-Belaz-Service (2018 Sales are UAH 0.8 billion).

Table 8 illustrates the import penetration indicators assessed for the selected VCs: Sales penetration and Production cost penetration rates.

Manufacture of machinery and equipment for agriculture and forestry has the highest relative and absolute import potential among the selected industries. Imported inputs contribute 1061-1341 UAH million in 2018. In relative terms, it is approximately 7-8.5% of VC sales and 9-11% of VC production costs.

In absolute and relative terms, manufacture of air, spacecraft and related equipment is the second largest importer. In 2018, it consumed approximately UAH 4-4.5 million of imported products: 5-8% of VC sales and 9-13.5% of VC production costs.

The third largest importer is repairing and maintenance of industrial machines and equipment. In 2018, its imports reached approximately UAH 598-754 million: 3-4% of VC sales and 4-5% of VC production costs.

Import, Sales and Production costs of repairing and maintenance of aircraft and spacecraft are negligible.

Companies of Agricultural machinery VC mostly import Tractors; (other than tractors of heading no 8709) (HS 8701), Flat-rolled products, width 600mm or more, clad, plated or coated (HS 7210) and Harvesting and threshing machinery, straw and fodder balers, grass or hay mowers; machines for cleaning, sorting or grading eggs, fruit or other agricultural produce (HS 8433). Firms import more than 270 commodity groups (at HS 4 aggregation level), but the top commodities cover approximately 27% of total VC import: UAH 234-340, 179-235 and 113-137 million respectively (Table 9).

Companies of Aerospace industry VC mostly import Turbo-jets, turbo-propellers and other gas turbines (HS 8411), Nickel; articles thereof n.e.c. in chapter 75 (HS 7508) and Titanium; articles thereof, including waste and scrap (HS 7202). Firms import more than 120 commodity groups (at HS 4 aggregation level), but the top commodities cover approximately 40-43% of total VC import: UAH 201-251, 200-250 and 100-150 million respectively.

# Chapter 4. Promising commodities to export from Canada to Ukraine

In our study "Canada-Ukraine Free Trade Agreement: Patterns and Tendencies" (2020)<sup>23</sup>, we analysed the CUFTA impact on Canada-Ukraine bilateral trade. One of the main outcomes of the research was identification of promising goods whose exports Canada could increase to Ukraine.

There were 2 criteria for the promising goods identification:

- Positive revealed comparative advantages in this product in Canada and negative in Ukraine;
- Significant potential for increasing Canada's exports to Ukrainian market based on the assessment of the gap between current and potential export volumes, or "undertrade" (estimated by the gravity model).

We identified 181 promising goods according to this methodology (Table D1, Appendix D). By comparing and matching these promising commodities with the list of the most significant imports of the target VCs (Tables C1 and C2, Appendix C), we can identify the most promising goods for intensifying Canadian exports to Ukraine through the selected VCs.

#### Donetsk and Luhansk oblasts

Table D2 (Appendix D) describes 17 promising goods for intensifying Canadian exports to Ukraine through VCs in DO/LO (at HS6 level). Table E1 (Appendix E) provides examples of specific commodities from HS6 group. Chain-by-Chain the most promising commodities are:

#### • Packaging and Cardboard:

Kraft paper and paperboard; sack kraft paper, uncoated, unbleached, in rolls or sheets, other than that of heading no. 4802 or 4803 (HS 480421) - Imports (2018) are UAH 20-25 million.
