

# The Core of Russia's Shadow Fleet

Identifying Targets for Future Tanker Designations

### **Executive Summary**

In this report – a follow-up to "Assessing Russia's Shadow Fleet: Initial Build-Up, Links to the Global Shadow Fleet, and Future Prospects," which was published by KSE Institute in June – we take a closer look at Russian shadow tankers to identify those that make up the core of the fleet employed to circumvent energy sanctions (i.e., the G7 price cap). The objective is to provide coalition governments with a priority list of vessels for future designations, which have proven to be extremely effective at removing ships from commercial operations. Addressing the Russian shadow fleet remains an urgent matter as another incident involving a tanker without proper insurance illustrates, even though it did not carry Russian oil in this case. The topic of the shadow fleet has received serious attention in recent weeks, including at the European Political Community Summit in July, when the new UK government garnered substantial support for its "Call to Action". Previously, Denmark had also been engaged in forming a coalition of countries to address this issue.

#### Our key findings are as follows:

- 1. A total of 307 shadow tankers carried Russian crude oil in at least one of the six quarters between January 2023 and June 2024. However, only a subset of these vessels were involved in each of the six quarters. Therefore, 45 tankers are considered to be part of the "core" shadow fleet for crude oil. They accounted for 28% of the overall crude oil shadow fleet's deadweight tonnage in H1 2024.
- 2. A total of 432 shadow tankers carried Russian oil products in at least one of the six quarters between January 2023 and June 2024. However, only a subset of these vessels were involved in each of the six quarters. Therefore, 41 tankers are considered to be part of the "core" shadow fleet for oil products. They accounted for 29% of the overall oil products shadow fleet's tonnage in H1 2024.
- 3. Of the 45 crude oil tankers and 41 oil products tankers identified as part of the "core" Russian shadow fleet, eight vessels have been sanctioned by the US, EU, and/or UK six transporting crude oil and two transporting oil products. Thus, a significant number of the vessels that Russia relies upon consistently to circumvent the price cap regime remain unaffected by such measures. In total, 64 shadow fleet vessels have been designated in the three jurisdictions since the fall of 2023.
- 4. New vessels were added to the shadow fleet in the first half of 2024, offsetting the capacity effect from designations. For crude oil, designated tankers have a deadweight of 6.05 million tons while "new" vessels amount to 8.90 million tons, of which 1.92 million tons of capacity are used regularly. For oil products, the corresponding numbers are 0.69 million tons, 8.15 million tons, and 0.98 million tons. Altogether, the shadow fleet's potential deadweight tonnage has remained largely unchanged.
- 5. Considering the *limited nature of the vessel designation campaign* and Russia's *ability to add new capacity* to its shadow fleet, it is not surprising that the shadow fleet's share of export volumes has increased in the case of crude oil to 89% in June 2024 and remained broadly stable in the case of oil products at ~35-45% in H1 2024. The *absence of capacity constraints* explains why the discount on Russian oil prices has not risen in recent months and export earnings have been robust.
- 6. To put additional pressure on Russia's ability to finance its war of aggression against Ukraine, we urge coalition governments to designate additional shadow fleet vessels, starting with those 39 crude oil and 39 oil products tankers that have been identified in this report as part of the "core" shadow fleet but are not sanctioned yet. Their removal would represent significant sunk costs, while forcing Russia to rely more heavily on mainstream fleet tankers, which fall under the price cap.



### Methodology

Classifying tankers as part of the Russian shadow fleet. As in our previous reports, we classify a vessel as part of the Russian shadow fleet if it does not have any restricted services relationships with price cap coalition jurisdictions, comprising the G7, the European Union, and Australia. These services include, most importantly, ship ownership, ship management, and insurance. Specifically, shadow tankers do not carry protection and indemnity (P&I) insurance by the International Group (IG), which covers oil spills.

Identifying regular operations of shadow fleet tankers. We use the term "quarterly voyage" if a shadow tanker performed a direct loading of Russian crude oil or oil products at a Russian port and delivered the cargo, either to a destination port or to another vessel via STS (ship-to-ship) transfer, at least once in a given quarter.<sup>2</sup> If a tanker performed quarterly voyages throughout a certain period (e.g., H1 2023, H2 2023, or H1 2024), we define it as a "regular" shadow fleet vessel. Finally, if a tanker performed quarterly voyages throughout the entire analysis period (i.e., Q1 2023-Q2 2024), it is considered part of the "core shadow fleet".

Determining the sanctions status of the shadow fleet. For the purposes of this analysis, we consider a vessel to be "sanctioned" or "designated" if it has been listed by the respective competent authority in the United States, European Union, and/or United Kingdom. For this report, we only examine vessels that have been designated in the Russia context and not any subject to similar measures related to, for instance, Iran. Altogether, we look at a total of 64 sanctioned vessels as of end-July 2024 – 49 crude oil tankers and 15 oil products tankers. For details on the designated vessels, please see Appendix Tables 4 and 8.

Data sources used for the analysis. Detailed information about voyages of tankers carrying Russian crude oil or oil products stems from Kpler, including data on the identity of vessels, cargo types and volumes, origin and destination ports, specific routes, and ship-to-ship transfers. For up-to-date information on the vessels in question, including their flag, registered owner, ship/commercial manager, ISM manager, as well as the addresses of all involved entities, we rely on *Equasis*. Finally, the current protection and indemnity (P&I) insurance status is determined through the website of the International Group of P&I Clubs.3

### Russia's Shadow Fleet for Crude Oil

### **Identifying the Core Shadow Fleet**




Figure 1. Russia's shadow fleet for crude oil

We determine that from January 1, 2023, to June 30, 2024, a total of 307 Russian shadow fleet tankers transported crude oil in at least one of the six quarters. This number is broadly consistent with previous findings, including those in KSE Institute's flagship report "Assessing Russia's Shadow Fleet", which was published in June. Here, we aim to identify the core of the Russian shadow fleet, however – tankers that are regularly and consistently used to circumvent the price cap regime and generate additional export earnings for Russia. According to our assessment, the number of regularly used<sup>4</sup> crude oil tankers increased considerably throughout the analysis period. If, during the first half of 2023, Russia used 86 such vessels, this number grew to 127 in the second half of 2023, and to 155 during the first half of 2024 (see Figure 1).

To identify the core of the Russian shadow fleet for crude oil, we take a closer look at the number of unique tankers that transported oil regularly during the entire analysis period (i.e., completed voyages in each of the six quarters). The overlap between sub-periods is shown in Figure 1. We estimate that 45 Russian shadow fleet tankers transported crude oil consistently over 2023 and the first half of 2024 (see Table 1). This leads us to conclude that the core fleet used by Russia is significantly smaller than the total number of 307 vessels identified above. Additionally, it indicates that many of the shadow tankers involved are not exclusively committed to Russian crude oil, but transport other cargoes regularly.

An analysis of the entities managing this core shadow fleet reveals interesting patterns. 28 out of the 45 regular tankers are managed by UAE-based **Stream Ship Management Fzco**. The company acquired these tankers from another UAE-based ship manager, Oil Tankers Scf Mgmt Fzco, which had previously obtained them from Russia's Sovcomflot. While both Sovcomflot and Oil Tankers Scf Management Fzco are sanctioned by the US, UK, and other coalition countries, the vessels continue to perform the same activities under new management (i.e., the transport of Russian crude oil). This suggests that the listing of ship managers is insufficient to address the shadow fleet challenge as vessels can be moved between entities very quickly. Stream Ship Management is heavily invested in the shadow fleet: It currently operates 37 crude oil tankers (and one chemicals/oil products tanker), of which 28 have been identified as part of the core fleet.

Our team has also consistently reported on and paid attention to tankers from this group in the monthly reports "Russian Oil Tracker." For instance, slides 19 and 20 of the <u>November 2023 issue</u> and slides 19 and 20 of the <u>February 2024 issue</u>.

Several other management companies deserve attention: Emirati Alqutb Alshamali Marine Services currently operates six crude oil tankers of which two are part of the core shadow fleet. This company entered



the market relatively recently, registering its first vessels only in November 2023, and represents another case of tankers being moved from a sanctioned entity to a new manager. Five of Alqutb's six tankers were previously operated by UAE-based Radiating World Shipping Services, which was sanctioned by the UK in December 2023. Due to such patterns, we believe that the company and its vessels require additional scrutiny. In addition to Emirati companies, a significant portion of the core fleet for crude oil is managed by Chinese entities, with three out of six tankers belonging to **Sunne Co Ltd**. Sunne Co Ltd. consistently ranks among the top-5 managers in terms of shadow fleet volumes. Despite only managing three vessels, the company accounts for ~5% of monthly volumes. The reason for this is the vessels' usage. Throughout 2023-2024, they have exclusively transported Russian crude oil to China – in most cases from the Russian port of Kozmino, allowing for a loaded voyage every two weeks. The remaining eight tankers that make up the core shadow fleet are managed by companies in Russia, Turkey, Azerbaijan, the Marshall Islands, and the Seychelles.

The 45 tankers identified as the "core" shadow fleet for crude oil play a critical role for Russia's ability to circumvent the price cap. They accounted for 28% of the tonnage of all "regular" shadow tankers used in H1 2024. However, only six of them have been designated by the US, EU, and UK.

### **Losses and Additions of Tankers**

Sanctions rather than voluntary decisions by operators appear to be the primary factor in terms of vessels exiting the shadow fleet. We find that nine tankers that were identified as regular participants in the transport of Russian crude oil in 2023 did not engage in such activities in 2024. Out of these, six were sanctioned by the US and one by the US and EU. The two other vessels that left the fleet are the Ionia, which only carried Russian crude oil once in May 2024 and the Koroglu, which operated exclusively between Azerbaijan and Turkmenistan in 2024. These findings show that concerns with regard to potential violations of the price cap are not what drives decisions to leave the Russian oil trade or remain engaged.

### While a small number of tankers exited the shadow fleet, Russia has also attracted new ones in 2024.

We identified 74 new shadow tankers for the transport of crude oil, which did not load Russian cargo directly in Russian ports throughout 2023, but have carried out at least one operation in 2024. A closer look at their usage shows, however, that only 15 should be considered as "regular" participants in the trade, i.e., they transported Russian cargo in both quarters of H1 2024. The new additions have similar characteristics than the overall shadow fleet: they are over 15 years old and, by definition, do not carry International Group P&I insurance. Notably, many involved entities only own or manage one vessel – typical for shadow fleet activities.

### Substitution of Sanctioned Vessels




Figure 2. Sanctioned shadow fleet crude oil tankers

Starting in late 2023, the US began to actively impose sanctions on individual tankers involved in the transport of Russian oil. In 2024, the EU and UK also began to adopt such vessel designations. As of the end of June 2024, 49 crude oil tankers have been sanctioned in one or more of these jurisdictions (see Figure 2). The US took such measures with regard to 34 vessels, the UK 12, and the EU 11.

Of the sanctioned tankers, 23 are managed by UAE-based companies, 15 by Russian companies, and 8 by Liberian companies. Many of the designated tankers were previously operated by entities that faced sanctions themselves, illustrating the relative ineffectiveness of entity designations. Other entities warrant further investigation. For instance, the eight sanctioned Liberia-operated tankers are owned/managed by companies that are only involved with one tanker each, but all are located at the same Monrovia address, suggesting the existence of shadow fleet ownership and management networks. Importantly, companies with this address own/manage an additional 24 tankers that are involved in the transport of Russian oil.

To assess the impact of these measures, it is important to evaluate changes in Russia's capacity for the transport of crude oil. The 49 sanctioned vessels have a deadweight of 6.05 million tons. While these have overwhelmingly been removed from commercial operations due to the threat of enforcement action against anyone interacting with them or the cargo they carry, 74 "new" vessels with a total deadweight of 8.90 million




tons carried Russian crude oil in 2024 while not having done so in 2023. We count only 15 of the 74 as "regular" (total deadweight 1.92 million tons) but the important point is that the other 59 could be used if needed and, thus, represent spare capacity. This shows that current designations have not actually removed capacity from the market - which limits the measures' impact on transport costs and export earnings. In addition, there are vessels that stopped carrying oil in 2024 (while having done so in 2023) for reasons other than sanctions and could be brought back. Their capacity is estimated at 2.91 million deadweight tons. Altogether, new capacity has essentially replaced what was removed (8.96 million deadweight tons) due to sanctions or the exit of vessels from the shadow fleet for other reasons. This explains why the share of Russian crude oil transported on mainstream fleet tankers has continued to decline in 2024 – standing at only 11% in June 2024 – thereby fundamentally undermining the price cap's leverage.

### Russia's Shadow Fleet for Oil Products

### Identifying the Core Shadow Fleet

We determine that from January 1, 2023, to June 30, 2024, a total of 432 Russian shadow fleet tankers transported oil products in at least one of the six quarters. To identify the core of the Russian shadow fleet - tankers that are regularly and consistently used to circumvent the price cap regime and generate additional export earnings for Russia – we look at vessels used during the first half of 2023, the second half of 2023, and the first half of 2024. In contrast to the corresponding analysis for crude oil, the number of tankers in regular use remains relatively stable at 131, 120, and 123, respectively (see Figure 3).

To identify the core of the Russian shadow fleet for oil products, we take a closer look at the number of unique tankers that transported oil regularly during the entire analysis period (i.e., completed voyages in each of the six quarters). The overlap between sub-periods is shown in Figure 3 and, despite the overall stable size of the shadow fleet, surprisingly limited. We estimate that 41 Russian shadow fleet tankers transported oil products consistently over 2023 and the first half of 2024 (see Table 2).

As for crude oil, a significant share of the core shadow fleet for oil products is managed by companies based in the UAE. Specifically, we find that 16 out of the 41 core fleet tankers are managed by Emirati entities, 8 by Russian ones, and 7 by Turkish ones. Out of the 16, 11 are accounted for by **Fornax Ship Management**, a company that emerged after sanctions were imposed on Russia's Sovcomflot and, subsequently, two other UAE-based ship managers, Sun Ship Management and Oil Tankers Scf Mgmt Fzco. Fornax exclusively operates tankers that were previously managed by these entities. Its total fleet consists of 27 vessels, 23 are oil products tankers or chemicals/oil products tankers. The company accounts for roughly one fifth of the shadow fleet's total oil products volumes. Fornax Ship Management (on the oil products side) and Stream Ship



Management Fzco (on the crude oil side), both based in the UAE, have effectively taken over the management of sanctioned tankers from the Sovcomflot chain and enable these vessels to continue the same operations.

Among Turkish companies, six out of seven tankers are managed by **Sand Gemi Isletmeciligi As**, which began acquiring vessels only in March 2024. This coincides with the cessation of operations by three other Turkish companies: Beks Tanker Isletmeciligi As, Beks Gemi Isletmeciligi Ve Tic, and Modern Gemi Isletmeciligi As. These three entities had been clear leaders in the shadow transport of Russian oil products from January 2023 to February 2024. Currently, Sand Gemi Isletmeciligi As operates a total of 11 tankers, all acquired from the three aforementioned entities. Fundamentally, the vessels in question have continued their regular operations – simply under new management. As a critical player in the chain of vessel management and the transport of Russian oil products, the company and its activities warrant closer scrutiny. We also find other, newly established Turkish companies operating oil products shadow tankers, although, for the moment, the number of vessels they manage and the amount of cargo they carry is limited: Cape Gemi Isletmeciligi As, Tokyo Gemi Isletmeciligi As, Global Tankers Ltd-Abb, Liya Shipping Ltd, Onn Denizcilik Ve Danismanlik, Crestwave Maritime Ltd, Oceanquest Maritime Ltd, Atria Denizcilik Ltd Sti, and Bluejourney Shipping Ltd.

The 41 tankers identified as the core shadow fleet for oil products play a critical role for Russia's ability to circumvent the price cap. They accounted for 29% of the tonnage of all "regular" shadow tankers used in H1 2024. Of the 41 core fleet vessels, only two have been designated.

#### Losses and Additions of Tankers

The majority of tankers exiting the shadow fleet did so for reasons other than sanctions. We find that eight tankers identified as regular participants in the transport of Russian oil products in 2023 did not engage in such activities in 2024. Out of these, only two – the Hs Legend and Sensus – were sanctioned by the US.

While a small number of tankers exited the shadow fleet, Russia has also attracted new ones in 2024. We identified 103 new shadow tankers for the transport of oil products, which did not load Russian cargo throughout 2023, but have carried out at least one operation in 2024. A closer look at their usage shows, however, that only 18 of the 103 should be considered as "regular" participants in the trade, i.e., they transported Russian cargo in both quarters of H1 2024. As in the case of the crude oil shadow fleet, the new additions are similar to the pre-existing shadow fleet: they are all over 15 years old and, by definition, do not carry P&I insurance by the International Group (IG). However, unlike in the crude oil case, the new "regular" vessels can be grouped by their management into a small number of categories: six are operated by Turkish companies, four by Chinese ones, and three by entities from the Seychelles.

Among the Turkish managers, three entities stand out: Jolly Holding Corp, Ledri Shipping Co Ltd, Liya Shipping Ltd, and Oceanquest Maritime Ltd. These each operate a single tankers. Interestingly, the tankers managed by Jolly Holding Corp and Ledri Shipping Co Ltd were acquired from one Greek manager, Dynamic Shipmanagement Sa-Lib. It is important to recognize that the six Turkish tankers already loaded oil products in Russian ports in 2023 but carried International Group (IG) P&I insurance at the time and were, thus, not classified as parts of the shadow fleet. They have become part of it since by being stripped of their remaining restricted-services – e.g., spill insurance – relationships with G7/EU jurisdictions – the main channel that we identified in our June 2024 report "Assessing Russia's Shadow Fleet".

As far as the Seychelles are concerned, Blossom Bridge Corp, New Dawn Marine Corp, and Zenith Shipping Inc-Sey operate one tanker each as well. It is noteworthy that all three managers share the same legal address in an offshore zone: Suite 10, 3rd Floor, La Ciotat, Mont Fleuri, Mahe Island Seychelles. This address is found for a significant number of managers transporting both crude oil and refined oil products from Russia. In our view, all companies sharing this legal address require a thorough examination of their activities.

#### Substitution of Sanctioned Vessels




Figure 4. Sanctioned shadow fleet oil products tankers

We again evaluate changes in Russia's transport capacity, here for oil products. The 15 sanctioned vessels (see Figure 4) have a deadweight of only 0.69 million tons. At the same time as these were largely removed from commercial operations, 103 vessels with a total deadweight of 8.15 million tons carried Russian crude oil in 2024 while not having done so in 2023. We count 18 of these 103 as "regular" (total deadweight 0.98 million tons) but the remainder should be seen as spare capacity that could be used if needed. As for crude oil, we conclude that **current designations have not removed capacity from the market**. In addition, there are vessels that stopped carrying oil in 2024 (while having done so in 2023) for reasons other than sanctions and could be brought back. Their capacity is estimated at 7.84 million deadweight tons. Altogether, new capacity has replaced 96% of what was removed (8.53 million deadweight tons) due to sanctions or the exit of vessels from the shadow fleet for other reasons. This explains why the share of Russian oil products transported on mainstream fleet tankers has remained broadly stable between late 2023 and the first half of 2024.

Of the sanctioned tankers, four tankers are managed by UAE-based Fornax Ship Management and three by Indian Maritas Fleet Pvt Ltd. The situation with the latter is particularly intriguing as Maritas Fleet Pvt Ltd is the ISM manager of 12 tankers and also has the status ship/commercial manager for four of them. All of the tankers linked to this company were designated by the US on January 18, 2024.

Some of the tankers had also transported Russian cargo in 2023, but did so only through STS (ship-to-ship) operations. For our definition of the involvement in the Russian oil trade, we focus only on vessels that physically entered Russian ports. This approach was chosen over one including STS operations as cargo transfer and conditions of the transport can be opaque in such cases.
